EXECUTIVE ORDER A-9-241
Relating to Certification of New Heavy-Duty Motor Vehicle

CHRYSLER CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102 and 43835 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That 1993 model-year Chrysler Corporation motor vehicles which have a manufacturer's gross vehicle weight rating (GVWR) of 8501 to 14,000 pounds are certified using the Otto-cycle engines listed below:



BE IT FURTHER RESOLVED: That the Executive Officer has been provided all material required to demonstrate certification compliance with the Board's emission control system warranty provisions (California Code of Regulations, Title 13, Section 2035 et seq.).

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
