Relating to Certification of New Heavy-Duty Motor Vehicles

AIRSTREAM, INC.

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102, and 43835 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code Executive Orders G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That Airstream, Inc. 1994 model-year motor vehicles which have a manufacturer's gross vehicle weight rating (GVWR) of 8,501 to 14,000 pounds are certified using the Otto-cycle engine listed below:



Engines certified under the Executive Order must conform to all applicable California emission regulations.
