Pursuant to the authority vested in the Air Resources Board by Health and Safety Code (HSC) Division 26, Part 5, Chapter 2; and pursuant to the authority vested in the undersigned by HSC Sections 39515 and 39516 and Executive Order G-45-9; and

Pursuant to the December 15, 1998 Settlement Agreement between the Air Resources Board and the engine manufacturer listed below, and any modifications thereof to the Settlement Agreement;

IT IS ORDERED AND RESOLVED: That the following diesel or incomplete medium-duty vehicles with a manufacturer's gross vehicle weight rating (GVWR) from 8,501 to 14,000 pounds are certified as described below. Production vehicles shall be in all material respects the same as those for which certification is granted.

BE IT FURTHER RESOLVED: That certification to the FEL(s) listed above, as applicable, is subject to the following terms, limitations and conditions. The FEL(s) is the emission level declared by the manufacturer and serves in lieu of an emission standard for certification purposes in any averaging, banking, or trading (ABT) programs. It will be used for determining compliance of any engine in this family and compliance with such ABT programs.

BE IT FURTHER RESOLVED: That the listed engine models have been certified to the **optional** emission standards and test procedures in 13 CCR Section 1956.8 applicable to diesel or incomplete medium-duty vehicles with a GVWR from 8,501 to 14,000 pounds and, therefore, shall be subject to 13 CCR Section 2139(c) (in-use testing of engines certified for use in diesel or incomplete medium-duty vehicles with a 8,501-14,000 pound GVWR).

BE IT FURTHER RESOLVED: That for the listed vehicle models, the manufacturer has submitted the materials to demonstrate certification compliance with 13 CCR Sections 1965 (emission control labeling), 1968.1 or 1968.1(m)(6.2) (on-board diagnostic systems; full or partial compliance), 1976(b)(1)(B) and (C) {evaporative emission standards}, 2035 et seq. (emission control system warranty), and 2235 [fill pipes and openings of motor vehicle fuel tanks]. (The braces {} are for gasoline, liquefied petroleum gas or alcohol fueled vehicles only.)

BE IT FURTHER RESOLVED: That the listed vehicle models are conditionally certified subject to the following conditions: (1) The Settlement Agreement is in effect; and, (2) The engine manufacturer is in compliance with all applicable certification requirements of the Settlement Agreement and any modifications thereof.

Vehicles certified under this Executive Order shall conform to all applicable California emission regulations. The Bureau of Automotive Repair will be notified by copy of this Executive Order.
