IT IS ORDERED AND RESOLVED: The following on-road motor vehicles with a manufacturer's GVWR over 14000 pounds are certified as described below. Production vehicles shall be in all material respects the same as those for which certification is granted.

BE IT FURTHER RESOLVED: For the listed vehicle models the manufacturer has submitted the materials to demonstrate certification compliance with 13 CCR 1965 (emission control labels), 13 CCR 1976(b)(1)(F) {evaporative emission standards), 13 CCR 2035 et seg. (emission control warranty), and 13 CCR 2235 [fill pipes and openings of motor vehicle fuel tanks).

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
