IT IS ORDERED AND RESOLVED: That the following Volvo Construction Equipment, Volvo AB, 1998 model-year engine, with rated power between 175 and 750 horsepower, and exhaust emission control systems are certified as described below for use in heavy-duty off-road equipment:
