EXECUTIVE ORDER U-M-4-12  
Relating to Certification of New  
Off-Highway Recreational Vehicles and Engines

YAMAHA MOTOR CO., LTD.

Pursuant to the authority vested in the Air Resources Board by the Health and Safety Code, Division 26, Part 5, Chapter 2; and,

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That 2000 model-year Yamaha Motor Co., Ltd. emission control systems are certified as described below for off-highway recreational vehicles:

Vehicle Type: All-terrain vehicle

Fuel Type: Gasoline


BE IT FURTHER RESOLVED: That the listed vehicles shall be subject to the procedures for in-use vehicle voluntary and influenced recalls, in-use vehicle ordered recalls, and in-use vehicle enforcement testing pursuant to the provisions of Section 2414, Title 13 of the California Code of Regulations.

BE IT FURTHER RESOLVED: That the listed vehicles shall not discharge any crankcase emissions into the ambient atmosphere pursuant to Section 2412(i), Title 13 of the California Code of Regulations.

BE IT FURTHER RESOLVED: That the listed vehicles shall comply with the emission control label provisions of Section 1965, Title 13 of the California Code of Regulations, pursuant to the requirements of Section 2413, Title 13 of the California Code of Regulations ("Emission Control Labels -- New Off-Highway Recreational Vehicles").

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
