This Executive Order is only granted to the engine family and model-year listed above. Vehicles, and engines that power such vehicles, in this family that are produced for any other model-year are not covered by this Executive Order. This Executive Order hereby supersedes and replaces Executive Order U-M-010-0006 dated July 10, 2001.
