IT IS ORDERED AND RESOLVED: That the engine and exhaust emission control systems produced by the manufacturer are certified as described below for off-highway recreational vehicles. The manufacturer shall ensure that character "C" or "3" is not used in the eighth (8") position of the vehicle identification number (VIN) of all vehicles in the engine family listed below. **BE IT FURTHER RESOLVED**: That the listed vehicles shall comply with 13 CCR Sections 1965 and 2413 (emission control labels).

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.

This Executive Order is only granted to the engine family and model-year listed above. Vehicles in this family that are produced for any other model-year are not covered by this Executive Order.
