Pursuant to the authority vested in the Air Resources Board by Sections 39150 and 39151 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Section 39023 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That Austin Morris Division of British Leyland (U.K.) Limited exhaust emission control systems for 1975 model-year passenger cars are approved for the engine family described below:

Engine Family: B/C  
Engine: 110 CID  
Exhaust Emission Control Systems: Air injection, exhaust gas recirculation, oxidation catalyst

Transmissions: 3-speed automatic, 4-speed manual  
Models: Austin Marina 2-Door GT  
Austin Marina 4-Door Sedan

Transmissions: 4-speed manual, 4-speed manual with overdrive  
Model: MGB Convertible

The following are the recommended values to be listed on the window decal required by California Assembly-Line Test Procedures for 1975 model vehicles:
