EXECUTIVE ORDER A-332-0005 New Zero-Emission Vehicles

Pursuant to the authority vested in the Air Resources Board by Health and Safety Code (HSC), Division 26, Part 5, Chapter 2; and pursuant to the authority vested in the undersigned by HSC Sections 39515 and 39516 and Executive Order G-02-003;

IT IS ORDERED AND RESOLVED: That the following vehicles produced by the manufacturer are certified as new zeroemission vehicles. Production vehicles shall be in all material respects the same as those for which certification is granted.

BE IT FURTHER RESOLVED: That the listed vehicle models shall not be equipped with any fuel-fired auxiliary power sources or heaters.

BE IT FURTHER RESOLVED: That the listed vehicle models shall comply with Title 13, California Code of Regulations, (13 CCR) Section 1965 (labeling).

BE IT FURTHER RESOLVED: That the listed vehicle models shall be clearly labeled as "low-emission motor vehicle" pursuant to the requirements of HSC Section 43802(a).

BE IT FURTHER RESOLVED: That because the vehicles certified by this Executive Order have no parts that affect emissions for which there is an applicable emission requirement, the manufacturer is not required to provide an emission control system warranty pursuant to HSC Section 43205 or 13 CCR Section 2035 et seq.

BE IT FURTHER RESOLVED: That the listed vehicle models are being certified as ZEVs at the request of the manufacturer. Nothing in this Executive Order is intended to constitute enforcement of any requirement that a percentage of the 2003 or 2004 model-year PCs or lightest LDTs certified and produced by a manufacturer must be ZEVs or otherwise meet any of the requirements of the 2001 ZEV Amendments for the 2003 or 2004 model year.

Quarterly production reports shall be submitted to the Executive Officer no later than 45 days after the end of each quarter.

Vehicles certified under this Executive Order shall conform to all applicable California emission regulations.

The Bureau of Automotive Repair will be notified by copy of this Executive Order.
