IT IS ORDERED AND RESOLVED: That the following exhaust and evaporative emission control systems produced by the manufacturer are certified as described below. Production vehicles shall be in all material respects the same as those for which certification is granted.

[emission control warranty], 2235 [fuel tank fill pipes and openings] (gasoline and alcohol fueled vehicles only), and "High-Altitude Requirements" and "Inspection and Maintenance Emission Standards" (California Exhaust Emission Standards and Test Procedures for 2001 and Subsequent Model PC, LDT and MDV).

BE IT FURTHER RESOLVED: That certification to the evaporative emission standards in 13 CCR 1976(b)(1)(B)-(C) listed above has been permitted pursuant to 13 CCR 1976(b)(1)(F)-Endnote 3(b).

Vehicles certified under this Executive Order shall conform to all applicable California emission regulations.
