IT IS ORDERED AND RESOLVED: The following vehicles produced by the manufacturer are certified as zero-emission vehicles pursuant to 13 CCR 1962 and the incorporated test procedures. Production vehicles shall be in all material respects the same as those for which certification is granted.

BE IT FURTHER RESOLVED: Because the vehicles certified by this Executive Order have no parts that affect emissions for which there is an applicable emission requirement, the manufacturer is not required to provide an emission control system warranty pursuant to HSC 43205 or 13 CCR 2035 et seq.

Quarterly production reports shall be submitted to the Executive Officer no later than 45 days after the end of each quarter.
