Pursuant to the authority vested in California Air Resources Board by Health and Safety Code (HSC), Division 26, Part 5, Chapter 2; and pursuant to the authority vested in the undersigned by HSC Sections 39515 and 39516 and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That the following exhaust and evaporative emission control systems produced by the manufacturer are certified as described below. Production vehicles shall be in all material respects the same as those for which certification is granted.

## BE IT FURTHER RESOLVED:

The exhaust and evaporative emission standards and the certification emission levels for the listed vehicles are as listed on the Attachment. Compliance with the 50° Fahrenheit testing requirement may have been met based on the manufacturer's submitted compliance plan in lieu of testing. Any debit in the manufacturer's fleet average compliance requirement for NMOG+NOx or Vehicle Equivalent Credit (13 CCR Sections 1961.2(b)(1), 1961.2(b)(3), 1961.2(c)(3), or 1961.4(d)(1), and the incorporated test procedures, as applicable), or Greenhouse Gas Emissions (13 CCR Section 1961.3, or 17 CCR Section 95663, and the incorporated test procedures, as applicable), for PC, LDT, MDPV or MDV shall be equalized as required.

## BE IT FURTHER RESOLVED:

For the listed vehicle models, the manufacturer has attested to compliance with Title 13, California Code of Regulations, (13 CCR) Sections 1965 [emission control labels], 1968.2 [on-board diagnostic, full or partial compliance], 2035 et seq. [emission control warranty], 2235 [fuel tank fill pipes and openings] (gasoline and alcohol fueled vehicles only), and "High-Altitude Requirements" (California 2026 and Subsequent Model Year Criteria Pollutant Exhaust Emission Standards and Test Procedures for PC, LDT and MDV).

#### BE IT FURTHER RESOLVED:

For the listed vehicle models, the manufacturer has attested to compliance with the applicable standard in Title 13, California Code of Regulations, (13 CCR) Section 1961.4(d)(2)(B) [partial soak standards].

## BE IT FURTHER RESOLVED:

For the listed vehicle models, the manufacturer has submitted materials to demonstrate certification compliance with the applicable standards in Title 13, California Code of Regulations, (13 CCR) Section 1961.4(d)(2)(C) [quick driveaway standards].

#### BE IT FURTHER RESOLVED:

The listed SFTP Interim In-Use Compliance Standard is applicable for the US06 test cycle only, in accordance with Title 13 CCR Section 1961.4(d)(3)(A)5.a.

Vehicles certified under this Executive Order shall conform to all applicable California emission regulations.

The Bureau of Automotive Repair will be notified by copy of this Executive Order.
