Pursuant to the authority vested in California Air Resources Board by Health and Safety Code Sections 43013, 43018, 43101, 43102 and 43104; and

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Order G-14-012;

Both Models support optional gas generator and auxiliary kicker motor. Generators pull fuel from same fuel tank (second pickup) as main engine using the same fuel line executive order listed for main engine for fuel supply hose. Auxiliary kicker motor pulls fuel from second fitting on main engine fuel filter using the same fuel line executive order list as main engine for supply hose. Both have Moeller Marine primer bulb installed in line with fuel supply line (EPA EO HMLRPLINEPB2-001).
