Both Models support optional gas generator and auxiliary kicker motor. Generators pull fuel from same fuel tank (second pickup) as main engine using the same fuel line executive order listed for main engine for fuel supply hose. Auxiliary kicker motor pulls fuel from second fitting on main engine fuel filter using the same fuel line executive order list as main engine for supply hose.
