IT IS ORDERED AND RESOLVED: That the following equipment produced by the manufacturer is certified as described below.



BE IT FURTHER RESOLVED: That the aforementioned equipment is exempt, pursuant to 13 CCR Section 2766, from (1) fuel tank permeation emissions standards and diurnal emissions standards described in section 2754 for engine displacement greater than or equal to 225 cc or (2) diurnal performance requirements in section 2754 and fuel tank permeation and carbon canister design requirements in section 2754(b) because it meets at least one of the exemption criteria listed above.

This Executive Order is only granted to the equipment models and model-year listed above. Equipment that is produced for any other model-year is not covered by this Executive Order.

This Executive Order hereby supersedes Executive Order U-U-006-0156 dated December 27, 2007.
