BE IT FURTHER RESOLVED: That the evaporative model emission limit (EMEL), as applicable, is the diurnal emissions level declared by the manufacturer based on diurnal test results for a worst-case engine or equipment model within an evaporative family. BE IT FURTHER RESOLVED: That the listed equipment models are conditionally certified based on evaporative emissions results generated using interim evaporative test data. The manufacturer is required to demonstrate full compliance with applicable evaporative emission standards and test procedures by August 31, 2021.
