The following are the exhaust hydrocarbon plus oxides of nitrogen (HC+NO<sub>x</sub>), carbon monoxide (CO), and particulate matter (PM) emission standards (Title 13, California Code of Regulations, (13 CCR) Section 2403(b)), and certification emission levels in grams per kilowatt-hour (g/kW-hr), and permeation standard (13 CCR Section 2754(b)), and certification level in grams per square meter per day (g/m<sup>2</sup>/day) for this engine/evaporative family or the component Executive Order. Engines or equipment models powered exclusively with alternative fuel as defined in Section 2751(b)(1) are exempt from complying with evaporative emission requirements. Engines within this engine family shall have closed crankcases in conformance with Section 90.109 of the "California Exhaust Emission Standards and Test Procedures for 2005 and Later Small Off-Road Engines," adopted September, 2003.



**This Executive Order is only granted to the engine/evaporative family and model-year listed above. Equipment in this family that is produced for any other model-year is not covered by this Executive Order.**
