opportunity for certification staff to spend less time reviewing material that has already been reviewed the previous year. In turn, it should provide manufacturers shorter certification processing time and a quicker Executive Order. Therefore, ARB staff has developed a streamlined certification process that will be applicable to "carryover" and "partial carryover" certification applications. This process would be an optional certification pathway available to manufacturers for speedy certification of those types of applications. The traditional certification process will remain available to all manufacturers who cannot or opt not to use this optional streamlined certification pathway.

Attached is a draft paper describing the proposed optional streamlined carryover/partial carryover process with appendices. The appendices include the certification checklists and cover letters.


