Air Resources Board (ARB or Board) staff invites you to participate in a third public workshop to discuss proposed amendments to the *Criteria for the Evaluation of Motor Vehicle Pollution Control Devices*, Title 13, California Code of Regulations (CCR), Sections 2220-2225 (Aftermarket Parts). These amendments would establish a procedure for approving non-original equipment manufacturer (OEM) aftermarket diesel particulate filters (DPF) intended as modified parts for 2007-2009 on-road heavy-duty diesel engines. ARB staff has scheduled a workshop to discuss its proposed evaluation procedure.

OEM on-road heavy-duty diesel engines model year 2007 and later are certified with exhaust aftertreatment systems, which typically include a DPF. An aftermarket DPF program would allow for additional replacement sources of exhaust aftertreatment parts for the end-user. Currently, OEM filters are the only option available to replace failed DPFs on diesel engines originally equipped with a DPF after expiration of the warranty period. *Vehicle Code 27156 and 38391* requires ARB approval before a person can install, sell, offer for sale, or advertise any device, apparatus, or mechanism intended for use with, or as a part of, a required motor vehicle pollution control device or system that alters or modifies the original design or performance of the motor vehicle pollution control device or system.

The proposed procedure will establish the criteria that ARB will use to evaluate whether non-OEM aftermarket DPFs meet the exemption criteria for *Vehicle Code 27156* and 38391. Staff has met with the manufacturers involved in the production of aftermarket DPFs, and other interested parties, to understand what issues or concerns they may have in complying with the procedure. Staff has proposed several changes to the procedure which will be discussed at this workshop.
