PUBLIC WEBINAR TO DISCUSS NEW TRAFFIC DATA USE IN THE

CALIFORNIA HYDROGEN INFRASTRUCTURE TOOL (CHIT)

Please join Air Resources Board (ARB) staff for a presentation and discussion of a new simulated traffic volume dataset that is being proposed for use in its California Hydrogen Infrastructure Tool (CHIT). CHIT is a geographical information system-based tool developed by ARB to help the agency make recommendations of locations for new hydrogen fueling stations to be funded under California Energy Commission grant programs. ARB pursued the development of this dataset in response to stakeholder comments from a previous webinar¹ that indicated similar information should be included in ARB's recommendations for hydrogen fueling station locations.

The discussion on March 3 will focus on the need for ARB to develop the dataset, the methods that were followed, and the planned implementation of the dataset. The first use of the dataset is expected to be reported in the upcoming 2017 Annual Evaluation of Fuel Cell Electric Vehicle Deployment and Hydrogen Fuel Station Network Development (to be published in July of 2017). Webinar participants are encouraged to provide feedback on the methods, the generated data itself, and the plans for its implementation.
