LOWER-EMISSION SCHOOL BUS PROGRAM GUIDELINES

The purpose of the Lower-Emission School Bus Program is to reduce California school children's exposure to toxic diesel particulate matter (PM) emissions and to smog-forming oxides of nitrogen (NOx) emissions. Begun in 2000 with the Board's approval of the Lower-Emission School Bus Program Guidelines, the program has provided \$66 million in General Fund grants to purchase new, lower-emitting school buses meeting the latest federal motor vehicle safety standards, and to retrofit in-use diesel school buses with exhaust emission control devices that significantly reduce toxic PM emissions.

In the spring of 2002, California voters passed Proposition 40, the California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal Protection Act. This measure provides a total of \$50 million over two fiscal years (fiscal years 2002-2003 and 2003-2004) to ARB to fund air quality projects. Assembly Bill 425 (Statutes of 2002, Chapter 379) directs that 20 percent of the Proposition 40 funds available to ARB shall be allocated for the acquisition of "clean, safe, school buses for use in California's public schools that serve pupils in kindergarten and grades one to twelve, inclusive." This appropriation from Proposition 40 funds provided \$4.92 million for the purchase of new, lower-emitting school buses statewide during the 2002-2003 fiscal year. At its

March 27, 2003, public meeting, the Board approved regional funding allocations for the 2002-2003 fiscal year Proposition 40 funds for new school bus purchases and approved updated program criteria for the expenditure of those funds.

For the 2003-2004 fiscal year, ARB has \$4.6 million available for new school bus purchases statewide. At the public workshop on March 12, 2004, the staff will present proposed regional funding allocations and proposed updated program criteria to reflect new engine emission standards for 2004 and later model year heavy-duty engines, and will solicit the public's input on the proposed revisions.
