SUBJECT: PUBLIC WORKSHOP REGARDING PROPOSED CONTROL MEASURE FOR HEAVY DUTY STREET SWEEPER VEHICLES OPERATED IN THE SOUTH COAST AIR BASIN

**Background:** Beginning in 2000, the South Coast Air Quality Management District (SCAQMD) adopted several rules as part of their Clean Fleets Program. These rules were designed to require certain fleets to purchase the cleanest alternative fueled vehicles available. The rules were challenged in court and in April 2004, the U.S. Supreme Court ruled that certain aspects of the fleet rules adopted by SCAQMD were federally preempted. The Air Resources Board (ARB or the Board) with the concurrence of the SCAQMD has agreed to initiate the rulemaking process for four of the following fleet rules:

- Rule 1186.1 Less-Polluting Sweepers
- Rule 1192 Clean On-Road Transit Buses
- Rule 1193 Clean On-Road Residential and Commercial Refuse Collection Vehicles
- Rule 1195 Clean On-Road School Buses

**Workshop:** ARB is holding a public workshop to solicit comments on a new proposed control measure for Heavy Duty Street Sweeper Vehicles Operated in the South Coast Air Basin based upon the requirements of Rule 1186.1. Briefly, staff is considering adopting the South Coast rule or a rule which requires best available control technology as state regulations. Preliminary regulatory concepts are attached. The draft of the actual regulatory language proposal will be posted at <http://www.arb.ca.gov/msprog/scfleet/scfleet.htm> at least two weeks prior to the workshop.
