SUBJECT: PUBLIC WORKSHOPS TO DISCUSS REVISIONS TO THE
CARL MOYER PROGRAM GUIDELINES AND NEW
AGRICULTURAL ASSISTANCE PROGRAM GUIDELINES

The Carl Moyer Memorial Air Quality Standards Attainment Program (Carl Moyer Program) currently provides incentive grants to reduce smog-forming emissions from heavy-duty diesel-powered vehicles and equipment. The Carl Moyer Program guidelines provide local air quality management and air pollution control districts with criteria for implementing the program and selecting grant applications.

Legislative changes in 2004 expanded the scope and funding of the Carl Moyer Program and created the Agricultural Assistance Program. The Air Resources Board (ARB or the Board) staff is in the process of revising the existing Carl Moyer Program guidelines, and developing guidelines for the Agricultural Assistance Program, to address the new requirements of the approved legislation. Proposed guideline revisions and new guidelines are scheduled to be presented to the Board at a public hearing on November 17, 2005.

Modifications to the Carl Moyer Program guidelines include revising the cost-effectiveness formula to include emission reductions of particulate matter (PM) and reactive organic gases (ROG) in addition to oxides of nitrogen (NOx), developing guidelines for on-road heavy-duty fleet modernization projects (vehicle replacement), revising project criteria to include additional agricultural sources of air pollution, and updating project criteria to reflect current engine emission standards and regulatory requirements.

One of the legislative changes allows light-duty vehicle programs, such as voluntary accelerated vehicle retirement (VAVR), to be funded through the Carl Moyer Program. To address this change, ARB staff is developing proposed Carl Moyer Program guidelines for light-duty vehicle programs, as well as changes to the existing VAVR regulations.

The 2005 Budget Act, signed by Governor Arnold Schwarzenegger on July 11, 2005, includes \$25 million of incentive funds to retrofit and replace older, higher-polluting school buses through the Lower Emission School Bus Program. Workshops regarding that funding will be held later this year and are not included in these Moyer Program guidelines modifications. This series of workshops will present proposed modifications to the Carl Moyer Program project criteria for each funding category including detailed funding examples and proposed project criteria for the Agricultural Assistance Program. The workshop format is intended to encourage detailed discussions of individual funding categories.
