SUBJECT: PUBLIC WORKSHOPS TO DISCUSS LOWER-EMISSION SCHOOL BUS PROGRAM FUNDING AND GUIDELINE REVISIONS

The staff of the California Air Resources Board (ARB or Board) invites you to participate in two public workshops to discuss Proposition 1B funding for the Lower-Emission School Bus Program and draft concepts for revisions to the Lower-Emission School Bus Program Guidelines (Guidelines). The Lower-Emission School Bus Program provides incentive grants to reduce school children's exposure to harmful pollutants through new bus purchases and through the installation of retrofit technologies on existing buses.

Proposition 1B, approved by California voters on November 7th, 2006, enacts the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006 to authorize \$200 million for replacing and retrofitting school buses. These funds have been appropriated to the ARB through the 2007 Budget Act signed by Governor Schwarzenegger on August 24, 2007, and will be implemented through the ARB's Lower-Emission School Bus Program.

The Lower-Emission School Bus Program Guidelines provide local air districts and the California Energy Commission with the criteria for selecting eligible school bus projects and the protocols for administering the program. At the workshops, the ARB staff plans to discuss draft regional funding allocations and draft concepts for revisions to the Guidelines. Copies of handouts will be available on site the day of the workshops. The workshops will be held at two locations:
