SUBJECT: PUBLIC WORKSHOP TO DISCUSS A PROPOSED REGULATION FOR
IN-USE ON-ROAD HEAVY-DUTY DIESEL-FUELED VEHICLES

The Air Resources Board (ARB or Board) staff invites you to participate in our next set of public workshops to discuss proposed regulatory language to reduce emissions from in-use on-road heavy-duty diesel-fueled vehicles. This regulation includes, but is not limited to: long and short haul truck-tractors, construction related trucks, agricultural trucks, wholesale and retail goods transport trucks, tanker trucks, package and household goods transport trucks, and any other diesel-powered trucks with a gross vehicle weight rating greater than 14,000 lbs. This regulation will not apply to heavy-duty vehicles covered by ARB's Solid Waste Collection Vehicles control measure, Transit Vehicle control measure or the On-Road Heavy-Duty Municipality and Utility Owned Truck control measure.

At the workshops, ARB staff plan to discuss revised proposed regulatory language, online survey, costs and cost methodology, and additional outreach efforts. The workshops will be held in Redding, San Diego, Sacramento, Fresno, El Monte, and Oakland at the dates and times listed below:
