SUBJECT: PUBLIC WORKSHOPS REGARDING THE HEAVY-DUTY VEHICLE GREENHOUSE GAS EMISSION REDUCTION REGULATION REPORTING REQUIREMENTS (TRACTOR-TRAILER GHG REGULATION) *REVISED*

The California Air Resources Board (Board) invites you to attend a public workshop for the Heavy-Duty Vehicle Greenhouse Gas Emission Reduction Regulation (Tractor-Trailer GHG Regulation). The workshop will provide training and an overview of the adopted Tractor-Trailer GHG Regulation including details on how to register using our online Truck Regulation Upload, Compliance, and Reporting System (TRUCRS) and information on how to meet the reporting requirements for 2010 and beyond. The TRUCRS reporting system is now available for fleets to upload their fleet information. ARB staff will also be available to answer questions about the regulation.

The June 10, 2010 Sacramento workshop will be available via webcast. You can watch the webcast by using the link on our webpage under "What's New." Staff also plans to add future dates and locations.
