SUBJECT: PUBLIC WORKSHOP TO DISCUSS CHANGES TO FUNDING  
OPPORTUNITIES BASED ON AMENDMENTS TO THE TRUCK AND BUS,  
DRAYAGE TRUCK, AND OFF-ROAD REGULATION

Air Resources Board (ARB or the Board) invites you to participate in a public workshop to discuss the proposed changes to ARB's Carl Moyer Program and recent changes to Proposition 1B Goods Movement Emission Reduction Program. Staff will describe changes to funding opportunities based on amendments to the Truck and Bus, Drayage Truck, and Off-Road In-Use regulations considered by the Board in December 2010.

In addition, ARB staff will discuss the proposed changes in the surplus methodology for the Carl Moyer Program. Staff of the Carl Moyer Program will present proposed changes to this methodology and to funding opportunities at the board hearing in April 2011.

The Proposition 1B Goods Movement Emission Reduction Program will discuss recent changes to the truck project specifications to better align with the amended truck regulation. These changes are being implemented via executive order to support the scheduled February to March 2011 solicitation for over \$100 million in new truck projects in all 4 trade corridors.
