SUBJECT: PUBLIC WORKSHOP TO DISCUSS CERTIFICATION FOR ENGINES FOR SPECIALLY CONSTRUCTED VEHICLES (KIT CARS, ETC.)

---

The Air Resources Board (ARB or Board) is currently considering a new procedure to evaluate and certify new engine packages intended for use in specially constructed vehicles (i.e., kit cars). Hobbyists choosing to install engines certified via the new procedure would be able to register their vehicle for use in California without needing to obtain a Certificate of Sequence from the California Department of Motor Vehicles and utilizing Health and Safety Code section 44017.4. Staff believes creating a certification path for such engine packages could result in emission benefits compared to existing specially constructed vehicle practices, and would offer a new option to hobbyists.

A workshop to discuss ARB staff's preliminary proposal was held on May 31, 2011, in Sacramento, California. Staff plans to hold a subsequent workshop on July 28, 2011 in El Monte, California to discuss staff's draft regulatory proposal, including draft regulatory language and certification procedures.
