**Background**

In recognition of the strong need and the agricultural industry's dedication to reducing their emissions, the State Legislature allocated \$135 million to CARB from FY 2017-18. The State Legislature directed the use of the monies to reduce agricultural sector emissions by providing grants, rebates, and other financial incentives for agricultural harvesting equipment, heavy-duty trucks, agricultural pump engines, tractors, and other equipment used in agricultural operations. CARB staff has developed and begun implementing the FARMER Program to meet the State Legislature's objectives and help meet the State's criteria, toxic, and greenhouse gas emission reduction goals.

In addition to the \$135 million allocation from FY 2017-18 currently being implemented in the FARMER Program, the State Legislature has recognized the need for further investments in cleaner agricultural vehicles and equipment and has allocated an additional \$132 million of the State's budget to the FARMER Program for FY 2018-19.

The FARMER Program is supported in part by California Climate Investments, a statewide program that puts billions of Cap-and-Trade dollars to work.
