EXECUTIVE ORDER A-38-16 Relating to Certification of New Motor Vehicles

PETERBILT MOTORS COMPANY

Pursuant to the authority vested in the Air Resources Board by Sections 43100 and 43102 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That 1980 model year Peterbilt Motors Company motor vehicles which have a manufacturer's gross vehicle weight rating greater than 8500 pounds are certified using the diesel engines listed below:
