



How to Report Publicly Funded Vehicles

Fleets that receive public or incentive funding to replace, repower, or retrofit one or more vehicles in their fleet have additional reporting requirements in DOORS, the California Air Resources Board's online reporting system for the In-Use Off-Road Diesel-Fueled Fleets Regulation (Off-Road Regulation).

Incentive funding is distributed through, but not limited to, the following programs: Carl Moyer Memorial Air Quality Standards Attainment Program (Carl Moyer Program), Incentives for the Purchase of Low-Polluting Construction Equipment (IPLPCE) for Public Agencies, the Off-Road Diesel Retrofit Showcase (Showcase), Supplemental Environmental Projects (SEP), and the Surplus Off-road Opt-in for NOx (SOON) Program.

The amount of compliance credit awarded for an action (i.e., the vehicle replacement, engine repower, or retrofit) in the Off-Road Regulation varies depending on the source of the funding. Steps to Reporting a Publicly Funded Vehicle

- A. Log into DOORS account and select your fleet**
- B. Report a replacement vehicle**
- C. Report an engine repower**
- D. Report a Verified Diesel Emission Control Strategy (VDECS)**
- E. Designate a vehicle as funded**
- F. Report funding information**

A. Log into DOORS account and select your fleet

1. Go to https://ssl.arb.ca.gov/ssldoors/doors_reporting/doors_login.html.
2. Use your User Name and Password to log into your account.
3. If you have forgotten how to access your account information, you can use the password retrieval option (see screenshot below) or contact the DOORS hotline at (877) 59DOORS (877-593-6677) or by email at doors@arb.ca.gov for assistance.

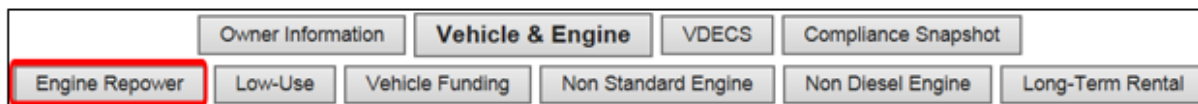

C. Report an engine repower

1. Using the navigation buttons at the top, select [Engine Repower]



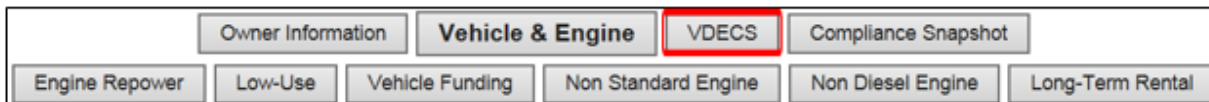

D. Report a Verified Diesel Emission Control Strategy (VDECS)

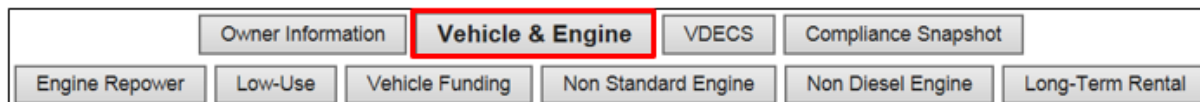
1. Using the navigation buttons at the top, select [VDECS].



2. Enter the VDECS serial number, VDECS family name, purchase date and installation date for the device on the "VDECS" page. E. Designate a vehicle as funded

1. Select [Vehicle & Engine] at the top of the page.



2. Select [Edit] next to the EIN of the vehicle that received public funding.
