

How to Report Engine Repowers

Repowering off-road diesel vehicles (i.e., replacing older, dirtier engines with newer, cleaner ones) is an important option for fleets complying with the turnover requirements of the In-Use Off-Road Diesel-Fueled Fleets Regulation (Off-Road Regulation). The Off-Road Regulation grants early credit for certain repowers performed on or before January 1 of the year prior to the fleet's first required compliance date.

To report an engine repower, you must first report the vehicle information as well as the engine information for the previously installed engine (i.e., the original engine or the removed engine).

Once your vehicle has been assigned an Equipment Identification Number (EIN), you may proceed to reporting the engine repower, as explained below.

A. Log into DOORS Account

- 1. Go to <u>https://ssl.arb.ca.gov/ssldoors/doors_reporting/doors_login.html</u>.
- 2. Use your User Name and Password to log into your account.
