

Verified Diesel Emission Control Strategy (VDECS) Information Page

This guide provides instructions on how to report a VDECS and definitions for the information required on the “VDECS” page of DOORS, which is the online reporting system for the In-Use Off-Road Diesel-Fueled Fleets Regulation (Off-Road Regulation).

Steps to Reporting VDECS

- A. Report VDECS Information
- B. Definition of Terms

A. Report VDECS Information

Note: You will only be able to enter VDECS information if you have already entered the vehicle and engine information.

1. Click [Add/Edit] next to the EIN for the vehicle for which you would like to enter VDECS information.

B. Definition of Terms

Field	Definition
EIN	This is a read-only field for the vehicle EIN that was generated on the "Enter Vehicle" page.
Veh Serial #	This is a read-only field for the vehicle serial number that was entered on the "Vehicle & Engine" page.
Your Veh #	This is a read-only field for the optional vehicle identifier that was entered on the "Enter Vehicle" page.
Eng Serial #	This is a read-only field for the engine serial number that was entered on the "Enter Engine" page.
Engine Purchase Date	This is a read-only field for the engine serial number that was entered on the "Enter Engine" page.
Eng MY	The engine model year is determined by the annual new model production period during which the engine was produced. The engine model year should be located on the
Eng hp	The engine's net horsepower (hp) or net flywheel power
VDECS Serial #	The VDECS serial number should be listed on the VDECS label or in the information provided by the VDECS manufacturer or installer. VDECS serial numbers may not repeat.
Date Purchase	The date the VDECS was purchased in yyyy-mm-dd format.
Date Installed	The date the VDECS was installed in yyyy-mm-dd format.
VDECS Family Name	Use the drop-down menu to select the VDECS family name from the list. The VDECS family name should be listed on the VDECS label or the information provided by the VDECS manufacturer or installer.
