
We are preparing early progress plans for the 8-hour ozone standard for five nonattainment areas: Coachella Valley, Eastern Kern County, Antelope Valley and Western Mojave Desert, Ventura County, and Imperial County. These plans will establish transportation conformity budgets for each area.

The Air Resources Board (ARB) is scheduled to consider approval of the plans at its February 28, 2008 meeting. To ensure that the transportation planning process can continue without disruption, we are requesting that the U.S. Environmental Protection Agency (U.S. EPA) begin parallel processing of these plans prior to ARB's February action.

The plans, together with supporting information, were posted on our website at: <http://www.arb.ca.gov/planning/planning.htm> on January 29, 2008. We will inform U.S. EPA if there are any changes to the plan documents after posting to the web.
