The Air Resources Board (ARB) is submitting to the U.S. Environmental Protection Agency (U.S. EPA) the 2013 PM2.5 Plan (Plan) for the Imperial County Air Pollution Control District (District). The District adopted the Plan on December 2, 2014 and transmitted it to ARB on December 9, 2014. ARB approved the Plan on December 18, 2014 as a revision to the California State Implementation Plan (SIP) for Imperial County.

The Plan includes the corresponding transportation conformity budgets. To ensure that any future updates to these budgets are used expeditiously in the conformity process, we request that U.S. EPA allow replacement of these budgets upon an adequacy finding for budgets in future SIPs. To accomplish this, we ask U.S. EPA to limit its approval of the budgets submitted today to last only until the effective date of future U.S. EPA adequacy findings for replacement budgets.
