SUBJECT: Revisions to the 2001 Clean Air Plan for
Santa Barbara County

Dear Mr. Kenny:

I am pleased to submit revisions to the 2001 Clean Air Plan for Santa Barbara County. This Plan was first approved by our Board of Directors on November 15, 2001, and is designed to meet both state and federal Clean Air Act mandates. It addresses all of the requirements for redesignation under Section 107(d)(3)(E) of the Federal Clean Air Act Amendments of 1990. More specifically, this Plan provides a redesignation request and Maintenance Plan for the federal one-hour ozone standard. This Plan also details how the current planning process satisfies both the Triennial Progress Report and the Plan Revision requirements for the state ozone standard mandated by the California Clean Air Act of 1988.

Since our Board's adoption of the 2001 Clean Air Plan, your agency has made several technical revisions to a very important component of our Plan – the on-road mobile source emissions factor model. We have worked closely with your staff to update the emissions associated with your latest model (EMFAC2002 Version 2.2) and have incorporated the revised emissions into our 2001 Clean Air Plan. Our analysis and consideration of the revisions find that the revised on-road mobile source emissions do not change the emissions control strategy contained in the Plan and that our maintenance demonstration remains intact.


