EXECUTIVE SUMMARY

The \$1 billion Proposition 1B: Goods Movement Emission Reduction Program (Program) is being implemented in California's four priority trade corridors, reducing freight pollution and the associated health risks in communities near seaports, rail yards, freeways, and distribution centers. Health and Safety Code section 39625 et seq. established the Program and directed the Air Resources Board (ARB or Board) to maximize emission reduction benefits while achieving the earliest possible health risk reductions. This report describes the progress of the Program through September 2015, including a listing of each grant with the funding amount, location, the number of trucks or other equipment that has been or are being upgraded, the timeframe for completion, and the expected emission reductions.

Of the \$1 billion authorized, ARB has allocated \$980 million for local agency projects and ARB's administration costs (\$20 million is retained by other State agencies for bond issuance and oversight costs). Of this amount, ARB has received or been approved for \$900 million in cash. ARB will need to request the remaining \$80 million to cover projects and provide for ARB's administration costs over multiple years. ARB awards and oversees grants to local agencies that in turn offer competitive incentives to diesel equipment owners to upgrade to cleaner technologies ahead of, or beyond, regulatory requirements. To ensure accountability and effectiveness, all grants are awarded in an open, public process as required by ARB Program Guidelines.

The local agencies have completed the Year 1 through Year 3 projects with over 9,500 diesel trucks replaced or retrofitted and operating in the four primary trade corridors. Additionally, 25 upgraded locomotives are operating in the Central Valley and Los Angeles/Inland Empire; grid-based electrical power was installed at 12 ship berths at the Port of Oakland and 25 ship berths at the Ports of Los Angeles, Long Beach and Hueneme; and 1 upgraded commercial harbor craft is operating in California waters. These projects will reduce over 4.2 million pounds of fine particulate matter (PM) and over 123 million pounds of nitrogen oxides (NOx) over the term of the contracts.

After the completion of the Year 4 projects, over 3,500 trucks and 2 harbor craft projects will be upgraded. These projects are estimated to reduce almost 300,000 pounds of PM and over 34 million pounds of NOx over the term of the contracts.

In September 2015, ARB approved \$220 million for Year 5 truck, locomotive, ships at berth, cargo handling equipment, transportation refrigeration unit, and commercial harbor craft projects. Local agencies are beginning to implement these projects and ARB estimates the reduction of about 700,000 pounds of PM and over 43 million pounds of NOx over the term of the contracts.

This status report provides an update on implementation of the \$1 billion Proposition 1B: Goods Movement Emission Reduction Program (Program) to reduce emissions and health risk from freight operations in California's priority trade corridors through incentives. Consistent with State law, the Program Guidelines for Implementation (Guidelines) and related documents detail the grant/contract requirements for the Air Resources Board (ARB or Board), participating local agencies, and equipment owners (see Program website at: <http://www.arb.ca.gov/gmbond>).

ARB adopts the Guidelines, then solicits, awards, funds, and oversees grants to local agencies like air districts and seaports. The local agencies offer grants or contracts, through a competitive process, to diesel equipment owners to co-fund the upgrade of diesel equipment to cleaner technologies ahead of or beyond regulatory requirements to do so.

To ensure accountability and effective use of these public funds, the local agencies: solicit for eligible projects; review applications; inspect the old equipment; provide data to rank competitively each piece of equipment based on emission reductions and cost-effectiveness; sign grants or contracts with equipment owners; inspect the upgraded equipment; make payment for the cleaner technology; and track/report on funded projects.

The information in this report is based on the local agencies' semi-annual project reports as of September 30, 2015, and supplemented with information in the Program's Goods Movement Online Database. The information is reported by year of funding, as defined below.

- Year 1: Awarded May 2008 Board Meeting
- Year 2: Awarded June 2010 and December 2011 Board Meetings
- Year 3: Awarded December 2011 Board Meeting - drayage truck projects only
- Year 4: Awarded July 2013 Board Meeting
- Year 5: Awarded September 2015 Board Meeting

Available Funding and Expenditures

Each budget appropriation authorizes ARB to use a specific amount of funding for the Program, within statutory timeframes. However, the appropriation does not provide any cash for this purpose. Therefore, the Program depends on the receipt of proceeds from State bond sales or other mechanisms to fund new projects.

The entire \$1 billion has been appropriated in State budgets (over multiple years), with \$980 million to ARB for this Program and \$20 million set aside by the control agencies to cover bond issuance and oversight costs. The final appropriation of \$240 million was approved in the Fiscal Year (FY) 2014-15 budget.

To date, ARB has allocated approximately \$980 million for local agency projects and ARB's administration costs over multiple years, and has paid about \$719 million to local agencies and for ARB's administration costs to date.

Current Status

The Board adopted updates to the Guidelines in June 2015, which is part of a periodic process to revisit the Program requirements. A Notice of Funding Availability to solicit projects from local agencies was released in July, and resulted in requests for \$469 million in Program funds. The Board awarded approximately \$220 million to five local agencies to upgrade diesel equipment and \$20 million for ARB's administration costs for the remaining years of the Program.

The local agencies opened solicitations for truck projects in mid-September, and solicitations for other source categories will be opened in late 2015 into early 2016. The local agencies expect to sign contracts with equipment owners beginning in mid-2016.

Project Results and Benefits

The Program bond monies have leveraged substantial match funding from private, local, and federal sources – more than one match dollar for every Program dollar invested.

Trucks. The local agencies have completed the Year 1 through Year 3 projects, resulting in more than 9,500 cleaner trucks operating in the four priority trade corridors. The local agencies are in the process of finalizing Year 4 projects and expect approximately 3,500 trucks to be upgraded with cleaner equipment. As of September 2015 over 2,700 trucks were operational.

The upgraded equipment includes approximately 1,600 trucks retrofitted with diesel soot filters and the replacement of over 460 trucks with new cleaner natural gas trucks. Small truck fleets (1 to 3 trucks) have received funding to upgrade about 4,800 trucks.

Ships at Berth. The Bay Area District's early grant project to install grid-based electrical power for three berths at the Port of Oakland has been operational since 2011. Under Year 2 grant projects, the installation of grid-based electrical power was completed in late 2013 for 9 berths at the Port of Oakland and 25 berths at the Ports of Long Beach, Los Angeles, and Hueneme. The funded berths were ready for ships to begin to plug into the grid in early 2014.

Locomotives and Commercial Harbor Craft. The Sacramento and South Coast Districts completed the upgrade of 25 locomotives that are operating in the Central Valley and the Los Angeles/Inland Empire trade corridors. In addition, the San Diego District has completed 3 harbor craft upgrades.

Benefits. When fully implemented, the Program expects projects included in this report will reduce over 5.2 million pounds, or 2,600 tons, of particulate matter (PM 2.5), plus over 200 million pounds, or 100,000 tons, of nitrogen oxides (NOx). Emission reductions for projects funded with Year 1 through Year 3 grants are calculated over the life of their grant term (e.g., 2 to 5 years for trucks and 10 years for ships at berth). Emission reductions for the Year 4 and Year 5 grants take into consideration ARB's regulations and include only the portion of the emission reductions that are early or extra to these regulations.

Implementation of Funds

Year 5. In September 2015, the Board awarded approximately \$220 million for truck, locomotive, ships at berth/cargo handling equipment, transportation refrigeration unit, and commercial harbor craft projects throughout the State. The award also included \$1 million for the truck filter substrate replacement program.

Year 4. In July 2013, the Board awarded approximately \$150 million for truck projects throughout the State, including funds for loan assistance. In addition, \$6 million was awarded for a truck filter substrate replacement program and nearly \$1 million for harbor craft projects.

Year 4 grants also include monies not utilized from prior year grants due to project fallout. Local agencies requested that these funds be made available to fund projects from the 2013 Truck Solicitations. ARB approved these requests, consistent with the priorities and procedures in the Guidelines.

The truck projects are expected to be completed in early 2016, the filter substrate replacement project by fall 2016; and the harbor craft project is complete. The local agencies have requested that unspent funds, due primarily to project fallout, be made available for Year 5 truck projects.

Year 2 and Year 3. ARB received funds for these projects in 2010 and 2011 from multiple bond sales. In June 2010, the Board awarded \$200 million in available cash primarily for truck projects and ships at berth/cargo handling equipment projects, with smaller grants for locomotive and harbor craft projects. In December 2011, the Board awarded and allocated approximately \$123 million from bond sales and funds redirected from ARB's administration costs for truck projects. All projects are complete. Any funds not utilized for projects were reallocated to Year 4 truck projects.

Year 1. The first year funds of approximately \$246 million were used for projects to upgrade trucks, locomotives, and ships at berth. All of these projects were suspended for 6 to 14 months due to the December 2008 "stop work" order on bond-funded programs, which resulted in an extended delay from time of application to contract. This led to some funds being unused by the local agencies; grant agreements were

amended to transfer funds from undersubscribed grants to oversubscribed grants. All projects are complete.

EXECUTIVE SUMMARY

Since 2000, the Lower-Emission School Bus Program (LESBP) has provided over \$300 million for purchasing new, lower-emitting school buses and for retrofitting school buses with diesel particulate filters. These projects are important steps in reducing children's exposure to the harmful effects of toxic diesel particulate matter emissions. The Air Resources Board (ARB or Board) administered State funds totaling just over \$100 million to replace 600 of the oldest, most polluting public school buses and retrofit about 3,800 other diesel school buses with ARB-verified pollution control equipment that significantly reduces toxic particulate matter emissions prior to 2006.

Proposition 1B authorized \$200 million in new incentive funding for ARB to reduce air pollution and the related health risk from diesel-fueled school buses through the LESBP. Under the LESBP Guidelines, ARB awards funding to local air districts; and the local air districts then solicit and review applications from school districts and execute, complete, and reimburse contracts to replace or retrofit in-use school buses. The Board approved the current version of the LESBP Guidelines in March 2008 and has allocated and disbursed over \$194 million to 35 local air districts with \$6 million set aside for state operations.

The deadline for LESBP Proposition 1B funding expenditure was extended twice; first from June 30, 2011, to June 30, 2012, and then, from June 30, 2012, to June 30, 2014, to allow time for remaining funds to be spent on cleaning up California's school bus fleet thereby protecting children's health from the harmful effects of air pollution.

Unspent LESBP Proposition 1B funds, including accrued interest that were not committed by an executed contract by June 30, 2012, were subject to transfer to another local air district that demonstrated an ability to fully expend funds by January 1, 2014. Local air districts had until June 30, 2014, to expend all funds and had until November 1, 2014, to enter data and submit final reports. Local air districts have reported executed contracts for 1,042 school bus replacements and 3,555 retrofits, obligating over 99 percent of the available Proposition 1B project funds and have returned less than \$50,000 in unspent funds.

Assembly Bill 110 (Blumenfield, Chapter 20, Statutes of 2013) authorized nearly \$700,000 of LESBP Proposition 1B funds from the \$6 million set aside for state operations, and Senate Bill 96, (Committee on Budget and Fiscal Review, Chapter 356, Statutes of 2013) directs the use of those funds in the LESBP. These funds have been encumbered and disbursed to the San Joaquin Valley Air Pollution Control District. So far, 38 retrofit projects have been funded statewide with these funds.
