

Click the camera icon at the bottom left of your screen to toggle your video on and off.






## **Raise Hand**


Click **Participants**, then **Raise Hand**. We'll also ask those on the phone.

- September 2020 CARB staff presented an informational update to the Board on California's air toxic program





# What are Air Toxics?

- Emitted from facilities such as chrome plating operations, oil refineries, auto body shops
- Cars, trucks, freight activity
- May cause cancer and other health impacts
- Addressed by California's
  Air Toxics Program








